## **Welcome to Classical Homeopathy**

I offer brief complimentary consultations in person or via phone to answer all of your questions. This also allows us to gain a sense of the compatibility of the relationship which is important in any health care setting.

When you visit me for the first time, I will need to learn about the state of your health in detail. A Medical and Personal History Record is required in advance of your initial appointment. The form is available for download and printing from the "Forms" page of my website. Initial visits are generally about 2 hours for children up to age 12 and 2-3 hours for adults and cover all of your concerns.

Following the appointment, I take time to review and work up the information, make a remedy selection and secure the remedy if it needs to be ordered. This may take up to a week generally. I will let you know when I have a remedy for you and exact directions for taking it. Between the first and second visit, I may ask you to phone or e-mail me. This contact enables me to keep your records up to date and remained informed of your progress. The initial fee covers the review of you records, initial appointment, work-up of the information, remedy selection and preparation as well as brief contact, if needed before the follow-up visit. Subsequent visits are scheduled from 2 to 8 weeks or more depending upon the intensity of your condition and progress being achieved. These visits are usually 45-90 minutes.

When calling, please remember to leave a contact number as I may not always be near your file. I attempt to return calls as promptly as possible, and generally do so twice daily, Monday through Friday. Once you are a client, I will take calls of an urgent nature, if necessary. During times that I am out of town, calls *may* be directed to a fellow homeopath, if of an urgent, or handled upon my return if of a more routine nature.
